





State and Territory Profile - New York

This profile highlights a current innovative effort to promote a subsidy system that is child-focused, family friendly, and fair to providers. It also provides demographic information, Early Care and Education (ECE) program participation and funding, subsidy innovation and program integrity information, program quality improvement activities, and professional development and workforce initiatives. Sources and links are provided at the end of the document.

Highlight of Innovative Effort

New York State Office of Children and Family Services (OCFS) created the Child Care Fraud Prevention and Detection Incentive Program in April 2012, a competitive grants program totaling \$1.3 million, to provide counties in New York State with resources they need to detect, prosecute, and prevent child care subsidy fraud. Mini-grants ranging from \$40,000 to \$100,000 were awarded to 19 counties plus the City of New York; maximum awards were tiered according to child population. Funds for this 12-month initiative are intended to be flexible and responsive to county needs and experience—launching fraud detection work in some counties and expanding it in others. Outcomes will be evaluated against each awardee's goals for fraud detection and prevention.

Q. Will Early Head Start Child care Partnership funding be targeted to areas of high poverty?


A. Applicants who propose to fill most of their funded EHSCC partnership slots with children from zip codes of concentrated poverty will have a competitive advantage.
