POINTS FOR CREATIVITY

Infant Toddler Child Development Associate

- ✓ Had to be tailored
- ✓ Needed a lot of coaching
- ✓ Help with writing & portfolio
- ✓ Had to offer the CDA in Chinese on Saturdays
- ✓ Each session had an incentive to ensure attendance

WHY IT IS WORTH THE RISK

- Parents like the 'homey' option for care
- Motivated providers earn more money with support for higher degree
- Impacts non-EHS kids in the FCC home
- Raises the quality of care for children in Your Community

TEACHER QUALIFICATIONS

Family Child Care

- Previous early child care experience and
- At a minimum, enroll in a Child Development Associate (CDA) program or an Associates or Bachelor's degree program in child development or early childhood education within six months of beginning service provision.
- Acquire the CDA credential or Associate's or Bachelor's degree within two years of beginning service provision.

Center Based

- Infant Toddler CDA, or been trained in early childhood development with a focus on infant and toddler development.
- 1 Teacher for every 4 children in group of 8

FCC PROGRAM OPTION GROUP SIZE 1306.20(G)(1)

- When there is one family child care provider, the maximum group size is six children and no more than 2 of the six may be under two years of age
- One family child care provider may care for up to four infants and toddlers, with no more than 2 of the four children under the age of 18 months

FCC PROGRAM OPTION GROUP SIZE

1306.20(G)(2)

- When there is a provider and an assistant, the maximum group size is 12 children with no more than four of the 12 children under two years of age
- Whenever present, the family child care provider's own children under the age of 6 years must be included in the count
- Additional assistance or smaller group size may be necessary when serving children with special needs who require additional care.
