Early Head Start Child Care Partnership

- NEW Federal funding opportunity
- \$500 million will be available through competitive funding opportunities in all states for new Early Head Start/Child Care Partnerships.
- These will be new 5-year-grants.
- Funding awards must be made by March 31, 2015.

Three Application Options

1) EHS-Child Care Partnership

- 2) Non-Partnership Early Head Start Expansion
- 3) Mix of EHS-CC Partnership and EHS Expansion

Applicant can only submit one application per service area.

Important Definitions

- Early Head Start (EHS)
- EHS Income eligible
- EHS Categorically eligible

Once determined eligible, an EHS child remains eligible until they transition into their next placement at age three.

Early Head Start Eligibility

By Income

Family size living below 100% poverty

Categorically Eligible

Children in foster care

Homeless children

Children in families receiving public assistance (TANF or SSI) are categorically eligible for Head Start and Early Head Start services regardless of income.



Funding by Layer










Layer I: Child Care Services




- Full-day full-year child care services.
- Funded by CC vouchers, subsidies, contracts, other
- If loss of subsidy occurs, only then could EHS funds be used, and only for EHS eligible children.







Layer II: Program-Level Comprehensive Services



Filling the gap in existing child care services


- Some CC may already provide these services.
- · Where gap in services, EHS funds may be used.
- These enhancements benefit all children.
- Costs must be reasonable and allowable.
- · Salary and benefit increases
- · Staff training to meet EHS requirements.
- Increased staffing levels to meet EHS child/staff ratios.
- · Equipment and supplies
- Minor facility improvements to meet health & safety requirements
- MH contracts to conduct classroom observations
- · Parent training
- · Other







Layer III: Individual Child Comprehensive Services



EHS-required individual services

Chargeable to EHS only when provided to EHS-eligible children.

Examples include

- Screenings for developmental, sensory and behavioral concerns
- Referrals to outside agencies (e.g. Part C for special needs).
- Assigned family service workers and visits
- · Home visits (teacher)
- · Infant formula, diapers.
- Programs encouraged to identify local resources to extend these services to all enrolled children.
- Other





Layered Funding Earns More Points

- 3 points if more than 40% of eligible children are receiving child care subsidy
- 5 points if the children being served live in a high-poverty zip code

Non-negotiables

- Early Head Start funds cannot replace existing CCDF or other funds used to operate the child care partner program.
- Existing child care funds must continue to cover ongoing child care costs.
- Early Head Start funds are layered on existing child care funds.
- Continuity of care is paramount.

The Role of Local Social Services Districts

Funding priority will be given to applicants that:

"can show evidence of broad-scale impact through changes in state [local] policies, including licensing that supports higher quality infant and toddler care or [other changes] that reduce the likelihood of families losing subsidies when family conditions change."

The GOAL...

... to keep infants and toddlers in the Early Head Start program until they turn 3-years-old.



The Tools in the Toolbox

- District autonomy and flexibility
- Waivers of selected regulations affecting a family's eligibility for subsidy, and/or the continuity of a child's participation in an Early Head Start child care program
- Expedited approval of waiver requests



Waivers

- Family Co-Pay Waive 18 NYCRR § 415.3(e) for families in receipt of child care in lieu of Temporary Assistance.
- Flexibility in Eligibility Periods Waive 18 NYCRR § 404.1(d) so as to match child care eligibility periods to the EHS Child Care Partnership program period regardless of changes in the parent's eligibility.

Another Waiver

 Flexibility in Reporting Changes in Family Circumstances – Waive 18 NYCRR § 415.4 (b)(2) that requires applicants and recipients to report immediately any change in financial circumstances, living arrangements, employment, household composition, or other circumstances that affect the family's need or eligibility for child care services.

(at least) One More Waiver

Pay for Enrollment – Waive 18 NYCRR §
 415.6(b), which allows districts to elect to make a payment on behalf of children who are temporarily absent. Districts selecting this option must indicate the number of days they will allow or if they have elected to not to limit the number of allowable absences

Expedited Approval

- 2-page pre-written letter, prepared by OCFS, with checkboxes
- Check the box(es) that represent your waiver request.
- Mail, fax, or scan the letter back to OCFS.
- Done!

Next Steps

- Application Due Date: August 20, 2014
- Expect contact from prospective applicants.
- Decide whether or not to request a waiver and, after public comment period,
- Receive expedited approval.
